## **CONFLICT FREE MINERALS STATEMENT**

January 13th, 2025

To Our Valued Customers,

Etlin-Daniels and Electrical Devices Inc. proudly support the SEC in their efforts to eliminate trade of "Conflict Minerals" which are defined as tantalum, tin, gold, or tungsten, regardless of where they are originated in the Democratic Republic of the Congo (DRC) or its neighboring countries.

The Securities and Exchange Commission (SEC) adopted final rules to implement reporting and disclosure requirements related to "Conflict Minerals," as directed by the Dodd-Frank Wall Street Reform and Consumer Protection Act. The rules require manufacturers to report on: (a) their worldwide use of Conflict Minerals in products they manufacture or contract to manufacture; (b) the cooperation of their supply chains in identifying the use of Conflict Minerals; (c) the country of origin for any Conflict Minerals; and (d) whether Conflict Minerals they use from the DRC region are "conflict free"

In order to eliminate the conflict minerals from our supply chain, Etlin-Daniels and Electrical Devices Inc. have taken the following steps:

- 1. We do not knowingly procure the specified metals that originate from the "Conflict Regions", nor do we knowingly source products that contain these metals that are not certified as "Conflict Free"
- 2. We have asked our suppliers to undertake responsible due diligence with their supply chains in order to provide us with certified, written documentation that raw materials used to manufacture components and products supplied to us originate from outside the "Conflict Region"
